Helpful **tips** and **information**.



To avoid scratching the device **do not use a blade** or similar sharp objects to open the packaging.

IP34 Device:

Protected against solid foreign objects over 1 mm in diameter. It also protects **against water splashes from any direction.**



When unpacking, place **soft padding** beneath the unit to avoid scratches and damage.



Operating instructions should be followed

SAFETY WARNINGS



Please read these instructions carefully before using your new heating unit

Always think about safety before you use the device. A few safety checks should therefore be carried out before each use.

- Protection category IP34: Protected against solid foreign objects over 1 mm in diameter. It also protects against water splashes from any direction.
- Although the heating unit is protected from splashes or jets of water, do not use it in the rain.
- This device is intended solely for domestic use and is not suitable for continuous operation.
- Make sure that the electric heating unit is free of any packaging material.
- Place the heating unit on an even surface.
- The heating unit becomes hot during use. Do not touch the hot surface of the heating unit
- **WARNING!** To minimise the risk of fire, textiles, curtains and all flammable materials should be kept at least 1 m away from the air outlet.
- Ensure particular care is taken when using the heating unit near children.
- The heating unit must not be left unattended while in use.
- Always disconnect the mains plug when the heating unit is not in use.
- Do not use the heating unit, if the plug or the power cable are damaged or if the device is malfunctioning or if there are visible signs of damage.
- Lay the electric cable so that there is no risk of tripping.

- Make sure repairs are carried out by specialists. Please follow the warranty conditions.
- Make sure that the socket is readily accessible if used on the move so that the plug can be quickly pulled out in case of emergency.
- Do not use this heating unit if it has been dropped.
- Do not use the heating unit in bathrooms, showers or in any area immediately next to a swimming pool.
- When turning the heater off, always ensure that the dial is set to the „0“ [OFF] position. Never disconnect the unit by pulling on the cable; instead pull the plug out of the socket.
- Do not allow any foreign objects to enter into the heating unit as these may cause an electric shock or pose a fire risk.
- To avoid the risk of fire, do not place any objects on or over the heater.
- Do not use in any locations where highly flammable substances, e.g. petrol or paint, are stored.
- Only use the heating unit for its intended purpose of heating.
- Do not allow children to play with the appliance.
- The heater must not be used directly beneath a plug socket.
- Ensure that the device has completely cooled down before storing it.
- If the power cord of this device is damaged, it must be replaced by the manufacturer, their service department or a similarly qualified person in order to avoid injuries.

- The device is not intended for use by persons with reduced physical, sensory or mental capabilities or lack of experience, by persons lacking knowledge or by children under the age of 8 unless they are supervised by a person responsible for their safety or receive instruction on how the device is used.
- Risk of death by suffocation/swallowing. Keep the packaging material out of reach of children and dispose of it immediately.
- Children younger than 3 years of age must be supervised at all times.
- Children between 3 years of age and 8 years of age may only switch the device on and off if they are supervised or have been instructed on how to use the device safely and have understood the dangers involved, provided that the device is in its normal operating position
- Children between 3 and 8 years of age must not set up, clean or carry out maintenance on the device.
- Children over 8 years of age may only use the device if they are supervised or have been instructed on how to use the device safely and have understood the dangers involved.
- Children over 8 years of age must not carry out cleaning or user maintenance without supervision.
- CAUTION! Some parts of the heater can get very hot and cause burns. Any children or persons requiring care must be very closely supervised.
- Do not use the heating unit with a timer switch which automatically turns on the heater as this poses a fire risk if the heating unit is covered or positioned incorrectly.
- The heater is not fitted with a climate control device.
- WARNING! Do not use the device in small rooms where

- there are individuals with limited mobility who are unable to leave the room on their own and where continuous supervision is not ensured.
- WARNING! To prevent the heating unit from overheating, do not cover it.
- The appliance is not to be used by persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience and knowledge, unless they have been given supervision or instruction. Children being supervised not to play with the appliance.
- Warning: Fire risk exists if the heater is covered by or positioned close to curtains or other combustible materials.

SAFETY INSTRUCTIONS



- Despite careful processing of all individual parts, individual components may have sharp edges. Therefore, please wear safety gloves to prevent cuts.

- Risk of death by suffocation/swallowing. Keep the packaging material out of reach of children and dispose of it immediately.
- When unpacking, check that all parts are intact and complete before initial commissioning.

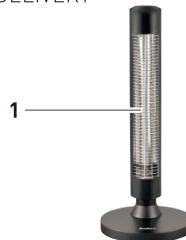

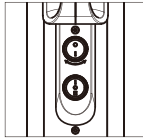


- Remove all packaging and protective film from the individual parts prior to assembly.
- Risk of death by suffocation/swallowing. Keep the packaging material out of reach of children and dispose of it immediately.

OPERATION

Connect the power cable with a 220-240 V, 10 A socket in a secure and dry location.

- The dial is used to switch on/off and control the settings of the device. [0] for OFF, [1] for 450 watts, [2] for 900 watts. When set to the last position (arrows), the oscillation function (approx. 60°) is also active.
- Although the heating unit is protected from splashes of water, do not use it in the rain.



- The plug should be disconnected from the socket after every use.
- The heater is fitted with an anti-tipping mechanism. If the heater tips over, it automatically switches off. Once the heater has been placed upright, it can be switched on again as normal. The anti-tipping mechanism must not be tampered with under any circumstances.



- When completely cool, the device can be adjusted both horizontally and vertically by 90°.
- Additional oscillation function (approx. 60°)
- Carrying handle on the rear of the unit

CLEANING/MAINTENANCE

SAFETY INSTRUCTIONS



- Hot surface: Make sure the ELECTRIC HEATING UNIT has cooled down sufficiently before cleaning.
- Once the heater has cooled down and has been disconnected from the power supply, the outer casing of the ELECTRIC HEATING UNIT may be wiped down with a dry cloth
- Never use corrosive or solvent products to do so

RISK OF FIRE AND EXPLOSION

- Do not use flammable cleaning agents.
- Do not modify the device or the mains plug.
- Parts sealed by the manufacturer must not be manipulated or modified
- Any maintenance work should only be carried out by a qualified electrician



- Wipe dirty surfaces with a dry cloth.
- When using a mild cleaning agents, also observe the notices/product information of the product manufacturer to prevent damaging the surface..



INTERNAL TROUBLESHOOTING

- The ELECTRIC HEATING UNIT is fitted with an anti-tipping mechanism. If the heater tips over, it automatically switches off. Once the heater has been placed upright, it can be switched on again as normal.
- In the event of any faults, please contact a qualified electrician or the manufacturer.

STORAGE/TRANSPORT

SAFETY INTSTRUCTIONS



- Make sure that the ELECTRIC HEATING UNIT is disconnected from the mains and has cooled down fully.
- Keep the device in a frost-free, dry location. Cover the device to prevent dirt

DISPOSAL
